Dr Jayanthakumaran has a PhD, 'Trade Liberalisation and Performance', from the Development Project Planning Centre, University of Bradford, United Kingdom. He is a senior lecturer in the School of Economics at the University of Wollongong (UoW). His recent research has focused on addressing knowledge and statistical gaps in relation to trade liberalisation and performance, poverty reduction, inequality, and inclusive growth mainly in Asia. Published 27 peer reviewed journal articles, 4 book chapters, 2 edited books and 1 book which are highly cited, some of which are cited by World Bank and local Australian newspapers.

Dr Jayanthakumaran has worked on many international projects and engaged in global tasks. He has been invited to be a consultant for International Confederation of Free Trade Union, Asia Pacific Regional Organisation (ICFTU/APRO) in 1995 where he produced a report on 'an overview of Sri Lankan Export Processing Zones (EPZs)' which was highly cited and accommodated in the APRO report on 'EPZs in Asia: who profits?'. He (with his colleagues in UoW) worked as a consultant for Asian Development Bank Institute (ADBI) on 'demographics, labour mobility and productivity' and as a consultant for Asian Development Bank (ADB) for book editing on the title 'Internal Migration, Urbanisation and Poverty in Asia'.

His demonstrated reputation in academic leadership is evidenced by the international citations of his peer reviewed journal articles, edited books, his consultancies with high ranking institutions such as ICFTU, ADBI and ADB, the completion of HDR students under his supervision and his teaching – research nexus. He has been a successful, innovative and popular lecturer by coordinating and teaching courses at the postgraduate and undergraduate Levels in UoW. There were 12 Higher Degree Research (HDR) students completed under his supervision to date and 9 peer reviewed journal papers co-authored with HDR students.
