Instructions on Filing a Motion to File

- DO NOT fill out the upper right hand corner of the document, it is for official Court use ONLY.
- All Motions must be typed and submitted via email to the Court Clerk
 - Exceptions are occasionally made and Motions may be submitted on paper to the Clerk or Student Government Administrative Assistant
- Common Motions and Definitions
 - Motion for Complaint or Motion for Request for Review
 - A party's request that the Court permit the party to present a complaint against another party.
 - Motion to Compel
 - A party's request that the Court order the party's opponent to respond to the party's discovery request. Discovery is a way to learn more about your opponent's case.
 - Motion for Default Judgment
 - A request by the plaintiff that the Court enter a judgment against a defendant who has failed to file a pleading or otherwise defend against a plaintiff's claim.
 - Motion to Dismiss
 - A party's request that the Court dismiss a case because of settlement, voluntary withdraw, or procedural defect.
 - Motion for Enlargement of Time
 - A party's request that the Court extend the time allotted to respond or to perform an action.
 - Motion for Judgment on the Pleadings
 - A party's request that the Court rule in its favor based on the pleadings filed with the Court, without accepting any evidence, because the outcome of the case is based on the Court's interpretation of the law.
 - Motion for a More Definite Statement
 - A party's request that the Court require an opponent to change a vague or ambiguous pleading to which the party is unable to adequately respond.
 - Motion for a Certified Question
 - A party's request that the Court issue an advisory ruling on a Constitutional, or other IPSGA document question.
- Be sure to support you case with facts and documentation of the constitution, bylaws, or other guidelines and documents.
- Be sure to include how your case falls under the jurisdiction of this Court.
- You may support your request by referring to the Rules and Bylaws of the Judicial Court, which may be requested in the Student Government Office in Walb Student Union.
- It is advised that you seek out a Counselor to the Bar of this Court; however, is not required for the Court to accept your Motion.
