WHEREAS, students at IPFW who achieve high grades in academic work deserve public recognition,

BE IT THEREFORE RESOLVED THAT section 9-B, of the Purdue at Fort Wayne Academic Regulations be amended as follows:

9-B. Honors Students

At the conclusion of each semester the Registrar at Indiana University-Purdue University at Fort Wayne shall indicate which undergraduate students were honors students in their scholastic work. Students who carry 12 hours or six or more in two consecutive semesters shall be listed

- on the Dean's list for earning a grade point average greater than or 1) equal to 5.5, but less than 5.75;
- 2) on the Vice Chancellor's list for earning a grade point average greater than or equal to 5.75, but less than 6.0;
- and on the Chancellor's list for earning a grade point average 3) equal to 6.0.

These three lists shall be posted in departments and in other appropriate places. Students on the Vice Chancellor's and Chancellor's lists for either of the two previous semesters shall be recognized at the Honors Convocation Program held annually on campus. There will be no academic honors list for the Summer Sessions.

Students on the Vice Chancellor's and Chancellor's lists for either of the two previous semesters shall be recognized at the Honors Convocation Program held annually on campus. There will be no academic honors list for the Summer Sessions.
