- b) changing the word "member" in the last sentence of the paragraph to the plural "members"; and
- c) changing the words "Faculty representatives" to "elected Faculty members."

BE IT FURTHER RESOLVED that section 5.3.4.8 be amended to read, "Advise the ex-officio members."
