Revised Associate of Science Interior Design Curriculum

Civil and Architectural Engineering Technology

Background Information

The faculty of Civil and Architectural Engineering Technology recommends the following curriculum changes:

Replace:

INTR 101 Architectural Design and Drawing

With

ARET 123 Construction Graphic Communication

ARET 123 will be required of all interior design majors and will become the foundation to subsequent drawing courses. Adopting this course will better prepare majors for industry as it introduces both manual drafting and CAD at the outset of the INTR curriculum. CAD will then be able to be introduced into subsequent program courses more easily.

Adopting the course will eliminate a duplication of courses within the department and will also facilitate incorporation of CAET department requirements into the INTR program.

Replace:

INTR 145 Art and Architectural Styles

With

ARET 210 Architecture and Urban Form

ARET 210 will be required of all interior design majors. Adopting this course will eliminate a duplication of courses within the department.

Replace:

INTR 212 Art and Architecture Styles II

With

MA 153 Algebra and Trigonometry I

MA 153 will be required of all interior design majors. Adopting this course will better prepare majors for industry as practitioners at every level are required to make mathematical calculations.

The course will introduce a necessary and missing component into the INTR curriculum. Adopting the course will also facilitate incorporation of CAET department requirements into the INTR program.

It is requested that the Assembly of Representatives approve the attached, effective fall semester 2000.
