PROCEDURES FOR DEALING WITH RESEARCH MISCONDUCT

The following procedure shall be followed in any situation related to research misconduct. The major phases of the procedure are the inquiry, a process of information gathering and initial fact-finding to determine whether an allegation or apparent instance of research misconduct warrants an investigation, and the investigation, which is the formal examination and evaluation of all relevant facts to determine if research misconduct has occurred. The inquiry and investigation are internal administrative and collegial proceedings and not judicial processes. An individual who is the object of an inquiry or investigation may be advised or represented by persons selected by the individual, the number of which shall be determined on a case by case basis by the committæ involved. All such assistance shall be obtained and rendered at the expense of the accused.

- 1. The initial allegation of research misconduct must be reported in writing to the school Dean or Director (hereafter Dean shall refer to Dean or Director). The written allegation must be signed but requests for anonymity will be considered and final decisions with respect to such requests shall be made by the school Dean.
- 2. Upon receiving such an allegation the school Dean shall inform the individual of the allegation and appoint a committee to conduct an inquiry into the allegation. The advice of the chair of the department involved may be solicited in appointing the inquiry committee. The committee shall be composed of three individuals selected for their expertise in the field of research involved.
- 3. The committee shall send a written report of the results of the inquiry to the accused and a copy to the school Dean.
- 4. If a majority of the inquiry committee votes that an investigation is not warranted, the report shall be securely stored in the office of the school Dean for as long as required by federal regulations and then destroyed.
- 5. If a majority of the inquiry committee votes that an investigation is warranted, the school Dean shall inform the Chancellor, who in turn shall inform the President of Purdue University that an official university investigation shall be made into the alleged research misconduct. Where appropriate, the President of Indiana University shall be kept informed. If required by federal regulations, the President of Purdue University shall notify the appropriate office of the involved agency. The school Dean shall inform the individual that an investigation will be conducted.
- 6. The school Dean, the Vice Chuncellor for Academic Affairs, and the Chair of the Faculty Affairs Committee of the Fort Wayne Senate shall jointly appoint a committee to investigate the allegation. The committee shall consist of not more than seven members unless the persons appointing the committee determine that a larger number is required in order to provide the required expertise on the subject and breadth of representation. The committee will elect it's own chair. The committee shall include at least one member who is a peer of the accused. Members of the inquiry committee may not serve on the investiga ion committee.

- 7. The investigation committee shall make available a written report of the results of the investigation to the accused and jointly to the school Dean, the Vice Chancellor for Academic Affairs, and the Chai⁺ of the Faculty Affairs Committee of the Fort Wayne Senate. The investigation must be completed within 90 days of its initiation unless circumstances clearly warrant a longer period.
- 8. The school Dean, Vice Chance or for Academic Affairs, and the Chair of the Faculty Affairs Committee of the Fort Wayne Senate shall jointly inform the Chancellor, who in turn shall inform the President of Purdue University, of the results of the investigation. Where appropria e, the President of Indiana University shall be kept informed. If required by federal regulations, the President of Purdue University shall provide a report to the appropriate office of the involved agency.
- 9. The accused and the inquiry and investigation committees shall have the privilege of presenting witnesses. Each such witness may be cross-examined by the accused or the committee involved. Pertinent records, exhibits and written statements may be accepted as evidence for consideration by the committee involved at the discretion of the Chair.
- 10. The inquiry committee's and the investigation committee's determination shall be made on the basis of whether it is more likely than not that the accused committed research misconduct.
- 11. There shall be a single verbation record, such as a tape recording, of all hearings before the investigation committee. The record shall be the property of Indiana University-Purdue University at Fort Wayne.

APPEALS

A decision reached by the investigation committee may be appealed by the accused to an appeals committee within five working days of receiving the decision. Such appeals shall be in writing and shall be delivered to the Vice Chancellor for Academic Affairs.

The appeals committee shall consist of not more than three persons selected for their expertise in the field, who shall be appointed by the Vice Chancellor for Academic Affairs.

Except as required to explain the basis of new evidence, an appeal shall be limited to a review of the verbatim record of the investigation committee and supporting documents for one or more of the following purposes:

- (a) To determine whether the invastigation committee's hearing was conducted fairly in light of the charges and evidence presented and in conformity with prescribed procedures giving the accused is reasonable opportunity to prepare and present a rebuttal to all allegations.
- (b) To determine whether each fac necessary to establish that the accused committed research misconduct was based on substantial evidence.

- (c) To consider new evidence sufficient to alter the decision, but only where such evidence was not known to the accused or could not reasonably have been discovered by the accused at the time of the investigation committee's deliberations.
- (d) The appeal must be completed within 25 days of its initiation unless circumstances clearly warrant a longer period.

MISCELLANEOUS

The duties of the investigation committee will be concluded with their report of the findings of fact. After the completion of any appeal or upon the expiration of the time for appeal, the administration of the university shall then determine appropriate sanctions, if any, arising from the committee's report, such sanctions being subject to established university disciplinary procedures, including relevant sections of Purdue University Executive Memorandum B-48 and the section of the current Indiana University Academic Handbook titled Code of Academic Ethics.

Determinations made under this policy as to the culpability of the accused and the findings of fact shall be deemed final, and all proceedings under existing University grievance procedures shall be limited to issues concerning the appropriateness of any sanctions imposed.

The timetable and requirements established by the Department of Health and Human Services for dealing with and reporting possible misconduct in science shall be applied to the fact-finding procedure.

Committees shall be appointed as promptly as reasonably possible under the circumstances. After appointment, each committee shall conduct its inquiry or investigation as promptly as reasonably possible consistent with tho oughness, fairness and impartiality.

All procedural questions not addressed by this policy are subject to the final decision of the Chairperson of the committee involved

At any stage of the inquiry, investigation or appeal, the Vice Chancellor for Academic Affairs shall be promptly notified if an i of the following conditions exist: (1) there is an immediate health hazard involved; (2) there is an immediate need to protect federal funds or equipment; (3) there is an immediate need to protect the interests of any person making the allegation or of any individual who is the subject of any allegation as well as his or her coinvestigators and associates; (4) it is probable that the alleged incident is going to be reported publicly; or (5) there is a reasonable indication of possible criminal violation.

POLICY AND PROCEDURES REGARDING RESEARCH MISCONDUCT

I. Purpose

This policy and the procedures for implementing it are intended to preserve the integrity of research at Indiana University-Purdue University at Fort Wayne; to establish due process for investigating and trying charges of research misconduct; and to ensure that the rights and standing of all those involved in such cases are protected. This policy applies to all faculty and professional staff employed at Indiana University-Purdue Ut iversity at Fort Wayne.

- II. Definitions
 - A. University: Indiana University-Purdue University at Fort Wayne.
 - B. Research: scholarly or artistic activity conducted at Indiana University-Purdue University at Fort Wayne or elsewhere if conducted under the auspices of this campus or Indiana University or Purdue University.
 - C. Research Misconduct: Fibrication, falsification, plagiarism, or other practices that seriously deviate from those that are commonly accepted within the academic community for proposing, conducting or reporting research. This definition does not extend to honest errors or honest differences in interpretation or evaluation.
 - D. Dean: Dean of the School or Director of the program in which the person charged holds appointment.
 - E. Inquiry: a process of information-gathering and initial fact-finding to determine whether an allegation or apparent instance of research misconduct warrants an investigation; an internal administrative and collegial proceeding, not a judicial process.
 - F. Investigation: a format examination and evaluation of all relevant facts to determine if research in sconduct has occurred; an internal administrative and collegial proceeding, not a judicial process.
 - G. Appeal: a review of the verbatim record of the investigation and supporting documents and/or consideration of new evidence.
- III. Professional Responsibilities

Each scholar, researcher and artist should:

- encourage integrity in research
- · discourage the pursuit of success at the expense of integrity
- assign credit and responsibility appropriately
- accept responsibility for the integrity of students and/or staff involved in research under her/his supervision
- conduct interpersonal relationships in a professional manner
- establish well-defined research methods
- maintain accurate and complete research records.

- IV. Principles and Parameters
 - A. Those who, in good faith, report suspected research misconduct will be protected against reprisals.
 - B. Those appointed to inquire into or investigate charges of research misconduct must be objective, must possess competence in the research field in question, must be free of real or apparent conflicts of interest or personal bias, and must be, to the extent possible, employees of this University.
 - C. Information concerning charges brought under this policy may not be disclosed except to appropriate university authorities, or in cases where required by law, to state or federal authorities.
 - D. Individuals charged with research misconduct must be informed of the charge and its particulars in writing immediately.
 - E. Due process for those charged must include, in addition to the notice described above, the right to cormunicate in writing and in person with any officers or committees appointed to conduct inquiries, investigations or appeals at any point during these processes prior to the formulation of conclusions; the right to be advised or represented by person(s) of their own selection at their own expense; the right to appeal findings on the basis of new evidence or violations of substantive and/or procedural due process; the right to appeal the appropriateness of any sanctions imposed; protection from adverse changes in employment status due to the allegations during the proceedings; and prior notification of any decision to disseminate information or to seek information about the research in question from others.
 - F. The University will appoint committees required by these procedures as promptly as possible, consistent with the circumstances. Each committee will conduct its phase of the process with due speed, consistent with thoroughness, fairness, and impartiality.
 - G. During the process, the Vice Chancellor for Academic Affairs shall be notified promptly if any of the following exist:
 - 1. an immediate health hazard
 - 2. an immediate need to protect federal or university funds or equipment
 - 3. an immediate need to protect the interests of any of the individuals involved in the process including, but not limited to, the accused, the accuser and those associated with either
 - 4. the probable public disclosure of the charges
 - 5. reasonable evidence of possible criminal violations.

The Vice Chancellor is responsible for taking appropriate action regarding these notifications.

- H. Committee determinations of culpability shall be made on the basis of a clear indication that research misconduct has occurred.
- Determinations made under this policy as to the culpability of the accused and the findings of fact shall be deemed final, and all proceedings under existing University grievance procedures shall be limited to issues concerning the appropriateness of any sanctions imposed.
- J. In cases where allegations of research misconduct have been made regarding federally funded research, the timetable and requirements established by the

U.S. Department of Health and Human Services for investigating and reporting research misconduct will govern the fact-finding procedures described in this document.

V. Procedures

- A. Inquiry
 - 1. Allegation: Charges of research misconduct must be submitted to the Dean in writing a id signed by the individual(s) making the allegations. Requests for anonymity are allowed, but the final disposition of these will be made by the Dean. An individual whose request for anonymity is denied shall have the right to withdraw the charges, ending the matter.
 - 2. Notification: The Dean will notify the accused in writing immediately.
 - 3. Appointment: The Dean will appoint a committee of three members sufficiently qualified to conduct an inquiry into the allegation.
 - 4. Committee Action: The Committee will select a chair, determine its method of inquiry and conduct its inquiry. Upon completion of its work, the Committee will report its findings and make a recommendation. supported by a majority of its members, to the Dean. A written copy of the findings and recommendation will be sent to the accused.
 - 5. Conclusion: If the Committee recommends that no further action is justified, the report will be stored securely in the office of the Dean for as long as required by applicable law or regulation and then destroyed. If the Committee recommends that an investigation is warranted, the Dean will inform the Chancellor, and the investigation process will begin.

B. Investigation

- 1. Notification: Upon notice from the Dean that an inquiry has recommended an investigation of an allegation of research misconduct, the Chancellor will notify both the President of Purdue University and the President of Indiana University. If required by law, contract, or regulation, the President of Purdue University shall notify the appropriate office of the involved agency.
- 2. Appointment: The Dean, the Vice Chancellor for Academic Affairs, and the Chair of the Faculty Affairs Committee of the Fort Wayne Senate shall jointly appoint a committee to investigate the allegation. The Committee must have at least three members, but may be larger if the appointing authority determines that a larger number is required to provide the required expertise and breadth of representation. One member must be a peer of the accused, that is, a faculty colleague if the accused is a faculty member, or a member of the professional staff if the accused is such; to member may have served on the committee of inquiry.
- 3. Committee Action: The Committee will select a chair, determine its method of invest gation, and conduct its investigation. The Committee must complete this process within 90 days of its appointment unless circumstances clearly warrant that an extension be granted by the appointing authority. The Committee must make provision for a)

witnesses appearing on behalf of the accused, the committee of inquiry and itself; b) cross-examination of witnesses by the accused or the committees; c) a verbatim record, such as a tape recording of all hearings, which shall become the property of the University, with a copy made available to the accused. Pertinent records, exhibits, and written statements may be presented as evidence, but the acceptance of such shall be determired by the investigating committee.

4. Reporting: Upon completing its work, the Committee will report its findings and recommendation to the accused, the Dean, the Vice Chancellor for Academic Affairs, the Chair of the Faculty Affairs Committee of the Fort Wayne Senate and the Chancellor. The Chancellor will report the results of the investigation to the President of Purdue University and the President of Indiana University. If required by law, contract, or regulation, the President of Purdue University will provide a report to the appropriate office of the involved agency.

C. Appeal

- 1. Petition: An accused may appeal the findings or recommendation of an investigating committee in writing to the Vice Chancellor for Academic Affairs within five working days of their receipt. Such appeal must be based upon one or more of the following: a) the discovery of new evidence; b) questions concerning the fairness of the inquiry and investigation process; c) questions concerning violations of procedural due process as set forth in this document; d) questions concerning the accuracy and the relevance of evidence cited by the committee of investigation in reaching its conclusions.
- Appointment: The Vice Chancellor for Academic Affairs will appoint a committee of three members selected for their expertise to consider the appeal. No member may have served on the inquiry or investigation committee.
- 3. Committee Action: The Committee will select its chair. In the case of appeals based on new evidence, it will determine whether the new evidence is sufficient to alter the conclusions and whether the evidence was known, or could reasonably have been known, by the accused at the time of the investigation committee's deliberation; in the case of appeals based on questions concerning substantive and procedural due process (1b, 1c, 1d above), the Committee will be limited to a review of the verbatim record of the investigation committee and supporting documents.
- 4. Report: The Committee must complete its work within 25 days of its appointment and report its findings to the Vice Chancellor and to the accused. The Vice Chancellor will transmit the results of the appeals procedure to those who received the earlier report of the investigation.
- D. University Action

After completion of the appeals procedure, or upon expiration of the time for appeal, the administration of the University shall determine appropriate sanctions, if any be necessary, arising from the findings and/or recommendation of the investigation or appeal committee. These sanctions must be in accordance with the relevant sections of Purdue University Executive Memorandum B-48 (or successor document) and/or the Indiana University Code of Academic Ethics.

 EXTENSION OF THE PEOBATIONARY PERIOD FOR JUSTIFIABLE CAUSE

DISPOSITION. TO THE CHANCELLOR FOR IMPLEMENTATION

PURPOSE: The academic performance of a probationary faculty member can be adversely affected by extraordinary personal circuinstances. Such circuinstances might include the responsibility as primary care giver after the birth or adoption of a child, serious personal illness, the provision of care for a seriously ill family member, or any similar situation requiring compassion. Such conditions may warrant deviation from the tenure policy.

To ensure consistency and fairness in determining which conditions are sufficiently justifiable to warrant deviation from the tenure policy, the following guidelines and procedures are recommended:

GUIDELINES:

- 1. Ordinarily, an individual may exclude no more than one year from the probationary period for justifiable conditions.
- 2. Normally, requests for exclusions must be made within one year from the time the conditions occurred which precipitated the request.
- 3. Exclusions will not be granted after the beginning of the penultimate year.
- 4. Decisions regarding whether or not requests for exclusions will be granted shall be based on.
 - a. verification that the condition: leading to the request occurred or continue to exist.
 - b. verification that the faculty member's performance prior to the conditions leading to the request warrants an excusion.
 - c. confirmation that the conditions for which the request is being made fall within the parameters of those deemec in these guidelines to be justifiable.
- 5. Faculty who have been awarded an exclusion shall have no requirements or expectations beyond those of any probationary faculty member.
- 6. Work accomplished during the excluded period may be cited in the promotion/tenure case.

PROCEDURES:

- Requests for exclusion shall be made in writing by the faculty member to the Vice Chancellor for Academic Alfairs, who in consultation with the faculty's Department Chair and Dean, will have the authority to approve exclusions for justifiable conditions.
- Requests for exclusions may be made at any time during each academic year up until March 15 of the academic year prior to the penultimate year. Decisions regarding requests will be made within 60 days of the receipt of the request.
- Any faculty member who feels it necessary to appeal a decision made under the above guidelines and procedures may utilitie the grievance procedures established for academic personnel.

The Rules Committee reports the results of two recent discussions:

- The Committee was asked to orientitie the meaning of the term "decision level" in SD88-13, Procedures for Promotion and Tenure, and determined that each enumerated section, 1.1 through 1.7, is a "decision level." The effect of this interpretation is to advise the Faculty that chief academic officers of departments or programs who are making a recommendation on a tenure or promotion case as provided in Section 1.2 of the tocument are ineligible for service on the campus tenure and promotion committee identified in Section 1.5 of the document.
- The Committee reviewed and reports to the Senate without recommendation an anomaly dictated by Indiana IW/SD80-2/Purdue FWSD80-3, Constitution of the Faculty of Indiana University-Furdue University at Fort Wayne, namely:
 - Article VII. A. 4. provides t' at "in each academic unit containing ten per cent or more of the Voting Faculty, the chief academic officer of the unit shall be allocated one of the unit's Senate seats."
 - Article VII. A. 2. provides that the chief academic officer of other units, who by IPFW practice are not Voting Faculty (because more than half of their duties are defined as other than teaching or other scholarly/creative work), may not serve, even by election, on the Seriate.

Thus, somewhat bizarrely, certain deans are required to serve on the Senate while all others are, in practice, forbidden to do so.


