In Memoriam

Beverly A. Hume

July 17, 2014

Beverly A. Hume, 63, professor emeritus of English, passed away on July 17, 2014.

A member of the IPFW Department of English and Linguistics since 1988, Beverly was a devoted professor and colleague, whose impact on her students and her colleagues was immeasurable. Beverly completed her undergraduate degrees from Shasta College (A.A.) and California State University, Sacramento (B.A.) before obtaining her Ph.D. from the University of California, Davis in 1983. Leaving her native California, Beverly moved to Atlanta, where she was a visiting professor at Emory University and the Georgia Institute of Technology. She resettled in Fort Wayne in 1988, where she made her mark as a teacher and scholar of American literature at IPFW. Her ethical disposition and her passion for teaching remain the hallmarks of her tenure at IPFW. Renowned for her critical work on Herman Melville, Edith Wharton, Mark Twain, and Charlotte Perkins Gilman, Beverly acquired a reputation as a scholar whose critical acumen allowed her to extract from her close readings of literature the historical, social, and intellectual surroundings of their authors. Reprinted often, Beverly and her scholarship had an impact in classrooms around the country.

Beverly was promoted to full professor in 2011 after establishing her role as a prominent scholar of American literature. Despite the success of her scholarship, or perhaps because of it, Beverly chose to devote her energies to her students and to the classroom. Many of her students later were admitted to graduate programs at some of the most prestigious universities in the country, and they remained in contact with her because of her role in contributing to their success. As one her students commented following her passing, "Now we know there is intelligent life elsewhere in the universe." Her encouragement of her students, as well as her dedication to the enriching power of literature to transform and effect social change, drew students to her classes to experience her generosity of spirit, her often ironic wit, and her trenchant understanding of the major figures of the American canon. In her honor following her retirement, the department established an award for students to celebrate their success as scholars of American literature. Beverly's spirit and her contributions to IPFW will endure.

Beverly is survived by her husband Craig Thorne and her sister Diana.

In Memoriam

David A. Legg

September 7, 1947 – July 5, 2014

Professor David Legg passed away in July 2014, at home with his family after treatment for cancer. At that time he was survived by his wife Colette; his children Alan, Eric (who more recently died), and Lisa; and his brother, Steve.

Dave was a graduate of Purdue University (B.S. 1969, M.S. 1970, Ph.D. 1973). He taught for a year at West Lafayette and then came to IPFW in 1974 as a professor of mathematics, and remained here for his entire career. He served as Chair of the Department of Mathematical Sciences from 2000 until 2012, and, at times, served in other administrative positions, including Associate Dean of the College of Arts and Sciences and Interim Assistant Vice Chancellor for Academic Affairs. He was a member of the Scientific Research Society Sigma Xi, and the long-time treasurer of the IPFW chapter. He was also a member of the Mathematics Honor Society Pi Mu Epsilon, and the Physics Honor Society Sigma Pi Sigma.

Dave's research in approximation theory and real analysis will be long remembered. He published over thirty papers in collaboration with 14 co-authors, including IPFW Professors Coffman, Dragnev, Huotari, Pan, and Townsend. His 2002 result on minimal energy points with colleagues Dragnev and Townsend, also known as the "Mastodon Theorem", was prominently cited this May by Henry Cohn of Microsoft Research during his School on Minimal Energy Configurations at the Constructive Functions 2014 International Conference in Nashville, TN.

Dave taught a wide range of courses from Calculus to graduate level real analysis. His students appreciated his commitment to their success in learning.

During his time as Chair of the Department of Mathematical Sciences, he served with outstanding professionalism and commitment. He was a Chair who would get things done. He kept a very large, very diverse, multi-disciplined department running smoothly. During his tenure the department exhibited an incredible growth in credit hours from 11,000 to 18,000. New programs, such as the Business Option and Computing Option in the BS in mathematics and the Graduate Certificate in Applied Statistics were developed. He guided us through our first two departmental program reviews, and followed up on the recommendations they contained. Many things came from those reviews, including the recently opened Math Assistance Learning Lab (or MALL).

The Department of Mathematical Sciences and IPFW have lost a great colleague. He will be missed.

- SUBJ: Creation of an ad hoc Committee regarding enrollment
- WHEREAS, IPFW has experienced declining enrollment for three years; and

Question Time

On August 12, 2014 Purdue President Mitch Daniels made this statement on Lakeshore public radio:

"The Higher Education Commission continues to remind folks, you're not there to offer doctoral programs. You're not there to do research. We have other places for that. You are there, in the regional setting, to provide an affordable option that prepares young people well for the careers that are available and the jobs that are being sought in the area where you live."

Leaders of the IPFW faculty senate responded immediately and appropriately refuting President Daniels' claims. President Daniels issued his response on August 18 to faculty leaders, admitting that ICHE allows for research and scholarly activity at the regional campuses for "the needs of [IPFW's] local and regional economies."

Throughout this, the administration has remained silent. Given the fact that President Daniels had to be reminded of IPFW faculty's mission, what is Chancellor Carwein's response to these series of events?

Moreover, President Daniels is teaching an Honors class in history about World War I at Purdue. While Purdue's decision to allow President Daniels to teach this class is its own business and none of ours, it does indicate that President Daniels believes that anybody with an interest in a subject is qualified to teach at the collegiate level. I am concerned that this is a mindset that will transfer to IPFW, as we are faced with more cutbacks and unfilled tenured positions.

Since IPFW remains under Purdue control, what specific plans does the administration have to not only ensure that qualified faculty will be teaching our classes, but also to protect faculty research and other creative endeavors?
