- 1. <u>Call to order</u>: R. Hess called the meeting to order at 12:01 p.m.

b. Purdue University:

J. Wilson:

1) The Indiana Commission for Higher Education recommended an increment in funding for IPFW that was

less than that requested for us by Purdue University, and far less than the amount that the Budgetary

Affairs Subcommittee believes is necessary to bring IPFW to a position of equity with other comparable

state-supported institutions. You might consider contacting state legislators with regard to needed

additional funding for IPFW.

10. <u>The general good and welfare of the University</u>:

W. Branson: At the November meeting, Senator Drummond raised a question about the Purdue Summer Savings

Plan. The Summer Savings Plan allows Purdue employees paid on a 10-month basis to have a portion of their

paycheck withheld and then paid out in the summer time. Prior to last summer there had been a choice of having

that paid in either two checks or three checks. Because the vast majority of people take the three-paycheck

method, Purdue dropped the two-paycheck method and started paying everybody with three paychecks during

the summer. The question came up relative to the anticipated move of the first fall paydate from the middle of

September to the last of August. Would these paydates in the summer change? The answer is, probably not. As

we look at the calendar and try to anticipate what those paydates might be and what the payroll decisions are, or

perhaps going to be, we don't think that we will see those paydates change at this point. Follow-up discussion

with Senator Drummond was that perhaps those summer paydates ought to be changed back to July 1 and

August 1, and we passed that along to the folks that set the payroll dates.

S. Hannah: Several people have suggested that, given the perhaps unprecedented series of losses to the campus

over the last month, we might take a moment as a campus to reflect, as Senator Wilson said, on those losses.

And so plans are moving forward to have such a campus event--probably the last week in January [note: it is

scheduled for February 1]. A number of folks will be getting together to plan how we might best do this. If you

have suggestions, please share them with me. Thank you.

R. Hess: I have a question. What day of the week is February 10?

J. Wilson: That is a Wednesday.

R. Hess: February 10 is the IPFW Alumni Bus trip for lobbying purposes. We want as many fresh faces and

pleasant people there as possible to talk to those people who make decisions about the resources for the campus.
