 - J. Haw presented SR No. 89-3 (Documents under Deliberation in Senate Committees and Subcommittees) for information only.

- 9. General good and welfare of the University:
 - J. Lantz: I would like to report to this body, which will also be in a letter to be distributed to faculty and staff this afternoon, that it appears that the bid for the Fine Arts Building will be okay. It was a little high; we are going to have to cut some things out. It will be going to the Purdue University Board of Trustees for action on Friday.... We will also be talking about the kinds of things that we need to do to be able to build the theatre. The architects are working on redesigning the theatre. Some of you may not have known that we needed another \$2 million to \$2.5 million dollars to build the theatre as designed. We have worked to try and raise that money. We raised a little, but we didn't raise all that we would have liked. I just wanted to bring you up-to-date on those two items since they've been dragging on for some time.
 - S. Hollander: Tomorrow, the Indiana University University Faculty Council will be meeting on this campus. It is the first time in a couple of dozen years almost that they have chosen to meet outside one of the core campuses. If you see strangers walking around with blind looks in their eyes tomorrow, please tell them where the union building is. If you would like to come, the meeting is from 1:30-4:30 p.m. in the Walb Union Ballroom. It is open to the public.
