- 1. Call to order: The meeting was called to order at 12:05 p.m.
- 2. Approval of the minutes of October 11, 1982: The minutes were approved as distributed.
- 3. Acceptance of the agenda:
 - W. Frederick moved acceptance of the agenda as distributed. Seconded. The motion passed on a voice vote.
- 4. Reports of the Speakers of the Faculties:
- a. A. Finco reported that the Purdue University Committee on Institutional Affairs is reviewing Fort Wayne Senate Document 76-20, Promotion and Tenure Policies, Criteria, and Procedures. He also said Purdue University is continuing its search for a President. The Intercampus Faculty Council is meeting on Wednesday to continue discussion on course equivalencies and student articulation within a program but between campuses.
 - b. M. Downs had no report.
- 5. Report of the Presiding Officer:
 - J. Giusti reported on the following:
 - a. A letter has been sent to our state legislators congratulating them after the election. The letter requests increased appropriations for compensation for this campus, although the amount of compensation is mainly determined by lobbying efforts of Indiana University and Purdue University, and stresses our need for an animal-care facility. Purdue University's letter to the legislators also requests the animal-care facility for us, and a copy of that request, along with Indiana University's endorsement, accompanied our letter.
 - b. Another letter was sent to the Great Lakes Valley Conference after a meeting with the presidents and the chancellors of both universities in Indianapolis. The letter tells the GVLC that we continue to be interested in membership and that a study of our competitiveness, community/student support, and resources will be conducted this year. After the report is concluded, it will be given to the Fort Wayne Senate for review and to the administration and the presidents for their consideration. The

letter compliments the Great Lakes Valley Conference on their quality, and ends with an expression of hope that they will continue their interest in us.

 - J. Haw indicated that SR No. 82-2 is the result of a request by J. Giusti last spring to the Educational Policy Committee to make recommendations concerning the Honors Convocation. Therefore, SR No. 82-2 is submitted to the faculty for their information.
 - J. Giusti said that, although SR No. 82-2 moves the Honors Convocation to the fall semester, there will be an Honors Convocation this spring so as not to miss any students.
 - H. Gibbons announced that this year's convocation will be held on Sunday, April 17, 1983.
- 9. The general good and welfare of the University: K. Wakley mentioned that the women's tennis team has completed its season with no defeats.
 - M. Downs moved a resolution congratulating the women's tennis team for their undefeated season. Seconded.

- M. Downs called the Library Endowment drive to the attention of the faculty, and urged all faculty who have not given consideration to contributing to the drive to consider it, and, if they decide to contribute, to please do so as soon as possible.
