The Senate took up consideration of SD 89-15 (Amendment of the 1990-1991 Calendar [SD 88-21]) which was postponed from the previous session.

The following motion was on the floor:

M. Downs moved to amend SD 89-15 by substituting for the calendar approved and recommended by the Educational Policy Committee the one approved and recommended by the Calendar Subcommittee. Specifically, the amendment would amend the 1990 Academic Calendar (\$D 88-21) such that (1) classes would begin on Thursday, August 23; (2) classes or reading period, at instructor's option, would begin Thursday, December 6; (3) the last week of classes would begin Thursday, December 13; an! (4) the semester would conclude after the last class, Wednesday, December 19. Seconded.

<u>S. Hollander moved to amend SD 89-19</u> by replacing the "Whereas" clause with: Resolved, That the IPFW Faculty Senate deplore as unprofessional conduct the sale of examination or professional review copies for profit either by individual colleagues or retail outlets." Seconded.

- <u>B. Bulmahn moved to amend the motion</u> by sending the document to the Faculty Affairs Committee rather than the Educational Policy Committee. Seconded.

W. Frederick presented SR No. 89-13 (Election of the Presiding Officer of the Senate) for information only.

- 9. General good and welfare of the University:
 - M. Downs: I would like to call this body's attention to a resolution which is going to be offered in Students' Government. Melanie Lane is here to explain the resolution and tell us about it. I would like to ask the body's permission to have her address us in connection with this resolution.

M. Lane (student senator): I am really excited. I found a company by the name of Indiana Fiber Recycling. I heard about it from different environmental things I am involved with. I heard very rave reviews. I called this group up and asked how much it would cost the university to get something going. The lady laughed at me. She said, "It won't cost you anything. We'll pay you." I quickly set a meeting between myself, Paul Strouts, Don Katter, and a lady from the Indiana Fiber Recycling by the name of Denise McAllister. She came in and gave a presentation on what their company does. What they do is bring out trash bins for paper.... Mixed paper we would not be paid a cent for, our waste management bill would go down because we would have less to dispose of. They would also have containers for white paper and one for computer paper, which the university would be paid for. There would be no charge for the containers or for pick-up. Economically, I think it is a wonderful thing for the university to do. Environmentally, I think it is also a very good step for us to make. There are a lot of activities going on with students. I have gotten a lot of calls. We have one student from the computing and data processing section who has made up an advertisement that when we get this started, it will go all across the university. We also have students who are willing to man the trash bins. There will be a little difficulty getting it started. Dr. Borelli has been very helpful in trying to help push this along. One of the main problems I see is going to be educating people to use the facility. Denise McAllister has volunteered to give her time free of charge to come out and talk with however many people however many times to say why it is important we recycle our paper. We have a lot of student support for this. I thought it was time to bring it to the faculty and let you know there are some good things going on environmentally and that you should be aware of them. Thank you for your time.
