The Purdue University Committee on Institutional Affairs is working with J. Carnaghi on the possible institution of early salary payment as described in Senate Document SD 83-10 (approved 1/16/84)...

The Inter-campus Faculty Council met on February 6. The autonomy document has been revised. The revisions include: (a) stressing the importance of students in transfer_programs being prepared at the same level on all campuses so they can compete in the remainder of their educations; (b) making changes in transfer policies subject to the approval of the Provost and the appropriate Chancellor; (c) limiting intercampus transfers for programs with a limited number of openings to in-state students, and monitoring other intercampus transfers more carefully; and (d) requiring students transferring into different degree programs at another campus to comply with the restrictions of that campus. The document is available for anyone who wishes to see it.

The Inter-campus Faculty Council is working on an extensive document which involves studying undergraduate courses offered on multiple campuses. W. Frederick and J. Lantz will be working with and discussing some of these things with various department members.

The next Inter-campus Faculty Council meeting will be in April. Items for this meeting may be given to any member of the Purdue University Committee on Institutional Affairs.

The eight faculty members who were appointed to this committee were nominated by this body's Nominations and Elections Committee. The other seven members came from a variety of sources.
