 - a. <u>Purdue University:</u> R. Barrett had no report.
 - b. <u>Indiana University</u>:
 - S. Hollander: The University Faculty Council was "iced out" on February 8. We have elected next year's representatives to the UFC. They are Michael Downs and Jeanette Clausen. (see SR No. 93-15)

- 8. <u>Committee reports "for jnformation_only": Nominations and Elections Committee D-</u> Legg:
 - D. Legg announced that S. Hollander had been unopposed and therefore declared elected as Speaker of the Indiana University Faculty and that F. Kirchhoff had also been unopposed and declared elected as Presiding Officer of the Senate. (see SR No. 93-15)
- 9. The general good and welfare of the University:
 - F. Kirchhoff At our last Senate meeting Senator Downs posed a question about the use of informal evaluation of administrators on this campus. Vice Chancellor Wartell will say something in response to that.
 - M. Wartell: The Chancellor and I had discussions after our meeting and I am now working with Dick Pacer and the Faculty Affairs Committee to come up with appropriate guidelines for the university.
 - M. Downs: That wasn't the question, even though that is a statement I applaud heartily. The Chancellor's answer to a question posed at the last meeting, that is, that there is no formal evaluation procedure existing at Purdue University nor would one be allowed here led to my question, which was if that is the case will we be allowed to use the formal procedures on this campus that some schools now use in evaluating administrators each year.
 - J. Lantz: It is my understanding that those are procedures that are agreed upon by the schools. To my knowledge there is nothing to stop that.
 - J. Brennan: Does that mean that if the campus here were to agree on a set of procedures that there would be no interference from Purdue?
 - J. Lantz: That is what Faculty Affairs is working on.
