- 9. <u>Committee reports "for information only": Educational Policy Committee (Senate</u> Reference

No. 98-18) – L. Wright-Bower:

- L. Wright-Bower presented SR No. 98-18 (Academic Calendar Formula for information only).
- 10. The general good and welfare of the University:
  - M. Nusbaumer: Over a year ago the faculty, in convocation, requested that the Senate engage in an evaluation of the senior administration of this University. I have heard nothing. I am curious as to where that process is?
  - J. Silver: It wasn't in response to the Faculty Convocation; it was a Senate policy passed last spring. They charged the Faculty Affairs Committee to update the Upward Feedback form and to arrange to have Upward Feedback conducted on an annual basis. The Committee has just recently completed the process of updating those forms and we will have on the next Senate agenda for information only copies of the forms and a description of how they will be distributed. At the same time we will begin the process of having those forms distributed and tabulated.
  - J. Haw: I have an announcement regarding General Education—a topic that has long concerned me. I have made it a personal project beginning late last semester to try to organize a grassroots, faculty effort to change our current General Education system. I have been consulting with a small group of concerned faculty. We hope to have a draft of an alternative General Education plan ready very shortly. My intention is to post that draft on the *issues du jour* bulletin board, probably late this week or early next week. I am hoping that **all** faculty will pay attention to this, think about it, and start a dialogue. Let us know your reactions positive or negative--make comments for changes. I am sure that we won't all agree on everything; the group that is working on it doesn't agree on everything. But I'd like to see what comes of this. Now I don't regularly read the bulletin

boards, I must confess, and I am sure that some other people don't either. So I do want to take this opportunity to alert you to the fact that this is coming and ask you to inform colleagues in your academic units that this is coming for discussion.

- M. Downs: At the same time, and in no way in conflict with what Professor Haw has mentioned, the General Education Subcommittee has solicited input from every department on campus regarding the General Education program that is currently in place. I think that the more discussion there is about General Education, the more likely we are to develop a General Education program that satisfies the largest number of faculty and moves us toward the goal of providing every student here with a good background early in their academic careers. I certainly hope everybody will take advantage of the opportunity that Professor Haw's group is offering them. I think it is also important that those of us on the General Education Subcommittee receive input as well.
- R. Hess: Professor Haw, do you anticipate that your group will be making recommendations to the General Education Subcommittee?
- J. Haw: This has not been worked out. The General Education Subcommittee's initiative is recent. I certainly welcome it. And, at the very least, I would propose to send the General Education Subcommittee a copy of the current plan that we are working on. I will stay in touch with the chair of that committee.
- K. McDonald: I have a question regarding the General Education Subcommittee: Have you already solicited or gotten that information from the various departments, or is it coming right now?
- M. Downs: It is in process.
- R. Manalis: I would clarify that. The committee sent out a questionnaire to the chairs of all the departments asking the chairs to dialogue with their faculty on that. So, see your chair.
- K. McDonald: I am the chair.
- E. Blakemore: I think it came from our dean's office. I think it went to the dean and then to the chair.
- R. Hess: Further discussion? I understand that we have an educational effort at State House Day on Wednesday. Those of you who can make it, please do so. I want to thank the Budgetary Affairs Subcommittee for its efforts. I think they've made a valiant effort and continue to do so on our behalf. We ought to support them in every way possible. I appreciate that.
- L. Hess: I just wanted to thank the folks that were involved in arranging the "Celebration

of Life" that we had last week. I appreciate the effort and that we were able to do that.
