- 8. <u>Committee reports "for information only": Agenda Committee (Senate Reference No. 89-15)</u> J. Haw:
  - J. Haw presented SR No. 89-15 (Documents under Deliberation in Senate Committees and Subcommittees) for information only.
- 9. General good and welfare of the University:
  - J. Lantz: I have two items that I would like to mention to the Senate. One is to remind you that the North Central evaluation team will be on our campus in early April. You have had considerable information about the report and when they will be here. We would like you to be alert to their visit. They may be asking to have individual appointments with many of you, so if you will try to keep your department office informed where you are during the time of their visit, it would be helpful to us. We look forward to having them come....

The second item I would bring to your attention is a letter that you should have received in your mail when you returned to campus. We have had a student with a confirmed case of measles, and there are certain at-risk groups that should pay particular attention to this problem--women who are pregnant and anyone who is under treatment for cancer. These people need to discuss the situation with their physicians. The Board of Health will provide to these at-risk groups, free of charge, blood tests if those are required by their physician. Students in your classes may be asking about this whole situation. We have worked with the Board of Health; they have not asked us to do anything special with our students. But we have recommended to students, particularly if they were born after 1957, that they consult with their physicians.

I have one other item. In December we brought to campus the Bairds, who came and looked at clerical, service, and administrative personnel. They spoke to groups and to individuals. We have had a report back from the Bairds, and last Thursday we had four meetings with staff members who were involved in the process. We have one more meeting scheduled for this afternoon for those people who were part of the study. After that meeting is over we will file a summary copy of that report in the Library.

J. Haw: I have been asked to issue a reminder to those academic units who have to elect Senators for next fall to please do so quickly so that your newly elected Senators can be consulted about their Senate committee preferences for next fall. Our committee elections are held in April.

- 10. <u>Memorial resolution:</u> D. Fairchild presented the memorial resolution for James Spencer Churchill. A moment of silence was observed.
