- 9. The general good and welfare of the University:
 - J. Lantz: I had a call on Saturday morning from Vice President Wilson of Indiana University. He advised me that the new Indiana University President would be named on Thursday evening. If that happens, they expect to do a "fly around" to visit all the campuses and we are scheduled for sometime on Saturday. I sorry I cannot give you any more information than that, but the moment I know whether there is going be a reception for the new IU president, I, will notify you by e-mail.
 - R. Pacer: The question came up at an earlier meeting-I believe it was Senator Bulmahn's question-concerning now or associate faculty. Vice Chancellor Wartell could not be at this meeting, but did ask me to report on that. He says there will be raises for associate faculty this year, it will not be across the board, but will be done on a merit basis.
 - D. Schmidt: This morning, upon arriving in the Manufacturing Technology Office, we discovered that the computer the secretary uses was stolen over the weekend. I want to point out that that could happen to anyone and you might want to take precautionary action.
 - M. Downs: Sometime ago the Higher Education Commission announced it was going to hold an open hearing on this campus. I believe the date was to be April 14. I was wondering if the administration had any information about that meeting?
 - J. I.antz: Dr. Rasmussen called last week and said they would not be holding the hearing on the 14th and had established no date for the hearing. When I hear when it will be, I'll let you know.
 - R. Hess: Some of us noticed in the paper that Ball State University is going to be offering summer-school courses at the undergraduate level at a local high school. What should our response to such invasion be?
 - J. Lantz: Vice Chancellor Wartell has discussed that with the Vice President of Ball State University two occasions. I have discussed it with President Bearing. I have a call

into the chair of the Higher Education Commission who has been out of town for a week. President Beering is discussing this with Clyde Ingle and will also discuss it with the President of Ball State.

- S. Hollander. I was happy to see that during this meeting we chose not to elect members of the Campus Appeals Board. I would urge members of the faculty who are asked to serve by appointment decline to do so.
- C. Butler: I forgot the policy, when a Senator goes on sabbatical for a year, does he or she resign?
 - F. Kirchhoff: Yes.
 - V. Coufoudakis: Realizing the problem we have with the student code of conduct and also having chaired the Campus Appeals Board for a number of years, I would oppose the statement made about abstaining from serving on that committee. We deal with a number of uses. Some are very important cases. If we do not have a method by which we can hear student cases of this type, we run the possibility of legal liability among other things. I would urge you that, while we are still trying to resolve our differences with Purdue University, the faculty who are asked to serve on that committee do serve in the interests of the university and the students.
 - J. Smulkstys: In *The Communicator* a student reporter contacted President Beering about the search for the chancellor and the student reporter indicated in her article that President Beering told her that the search committee had not been disbanded. I would like to ask the members of the committee who are here how they feel on that question.
 - S. Argast: There is nothing to report.
