Senate Reference No. 08-24 (End-of-the-Year Committee Reports) was presented for information only.

10. The general good and welfare of the University:

M. Wartell: In the tradition of our speakers and presiding officer, I want to thank everybody for serving. It really takes a part of your day and commitment to the university, and the university needs that. We need to have faculty governance – we need that participation. We make decisions better that way.

With respect to the budget for next year, the Senate just came out with their budget. It is better for us than the previous several iterations of the budget; however, as one of our West Lafayette colleagues said to us, "Enjoy it for a week, that is about how long it will last." The good aspect with that budget is that we increase our total budget by about 1.5 percent, which is the secondlargest increase among four-year institutions. That part is very nice but, as I said, it will not last and will change. The governor has already criticized it significantly, as you may have seen in the papers. We will just have to see what happens. At this point, we simply do not know.

On the very positive side, though, you probably read about the Lilly Foundation grant: the \$20 million economic development grant from Northeast Indiana companies and the Lilly Foundation. That grant includes \$4.5 million that will go directly to IPFW: one new endowed position in systems engineering and one new endowed position in wireless communications plus about \$1.5 million for laboratory upgrades in engineering. That is a very welcome increase in our funding.

We also will have access to the approximately \$15.5 million in addition that is in the grant, and there is a lot of training money in there: a lot of support money for STEM (science, technology, engineering, mathematics education). That will also be available to us, but it is hard to tell exactly how much we will manage to compete for.

A great deal of credit for writing the grant and for inserting the ideas into it go to Carl Drummond and to John Stafford from Community Research Institute. That is a very positive aspect.

The year has ended on a reasonably positive note. The trouble is that the year has not yet ended.

K. McDonald: As I was going through my sample ballot, I couldn't help but think about the amount of paper we are going through. I wondered if there was a way for us to have the election information online.

M. Walsh: Are you proposing that we distribute the sample ballots online or that we actually conduct the election online?

K. McDonald: Just one would be nice - probably the sample one.

M. Walsh: Doing the sample ones online, putting that up just on the Senate website, is very straightforward, and we could certainly do that. Running the elections online would be doable. It would take a little bit more work to do it and make sure it is secure, but I am pretty sure we could work with the people in IT Services to set that up.

K. McDonald: It is just something that occurred to me as we are trying to cut costs.

M. Nusbaumer: Just to follow up on Senator McDonald's comments, the Executive Committee has looked also at the distribution of paper minutes and agendas and trying to reduce some of that. I think it would be wise. Hopefully next year the Executive Committee can take a wider look at and make recommendations regarding the amount of paper we are using and reduce that.

S. Davis: One of the things we did do regarding that this year, in the Executive Committee, is we will only be sending hard copies to senators next year, and electronic copies to all the secretaries who can then distribute them if they wish. That was our first attempt.

We just have to make sure, as far as the voting, that we check with the Bylaws or run it by Andy Downs, because one of the things we lose with electronic voting is the open nominations. I see no problem with the sample ballot. We need to make sure we stay within the Bylaws.

M. Walsh: We should be able to find a way to work that in.

M. Wartell: One more issue I forgot to mention is that the IPFW baseball team beat the West Lafayette baseball team two out of three. That is another positive note.
