# b. <u>Purdue University</u>:

J. Silver: I attended the Purdue University Board of Trustees meeting on April 6.The major item on their agenda at that meeting and for the past several months has been strategic planning. This is going to play a large role in the decisions of resource allocation and planning for rebuilding. - 10. The general good and welfare of the University:
- J. Grant: I want to express appreciation to the students and faculty who are holding the Earth Day celebration on campus this year, especially the young students and the many departments who are working very hard on this. Representatives from SCREAM (Students Creating Respect for the Environment through Awareness and Mobilization) are very active in this project and, I think, our future is in very good hands with students like these.
- M. Nusbaumer: At the last Senate meeting we had a report on the legislature with regard to the budget. Since then they have announced a \$1 billion shortfall. Has there been any update on where that puts us?

- W. Branson: Over the last week or so we're hearing a lot more verbiage about tax increases to try to offset some of these things. There seems to be some positioning on that. The latest guess is that we'll hear the governor's response sometime this week. We are very quickly approaching the end of the session without a budget. Something needs to happen—they will need to extend the session or go into special session. Legally they haven't done what they're required to do in passing a budget yet. I wish we knew more.
- D. Oberstar: Does anyone know whether or not the legislature itself has begun discussions about the budget in the light of this rather large shortfall?
  - W. Branson: There is a House budget passed and a Senate budget passed and now the budget goes to Conference Committee. I am assuming that the Conference Committee will take this information and digest it and try to come up with a working budget. As far as specific discussions, I am not aware of anything at this point. They have to be going on.
  - L. Wright-Bower: Any other comments? Hearing none, I will say that it has been a privilege and an honor to serve as the Presiding Officer of the Fort Wayne Senate and I look forward to another term next year.
